

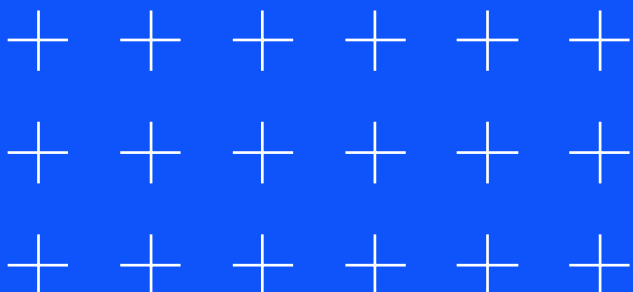

POSITION SUMMARY

To assist qualified radiologists in the reporting of a range of investigations and performance of relevant procedures at fellowship level, and to become progressively responsible for this themselves under qualified radiologist supervision.

DEPARTMENT DESCRIPTION

With a commitment to advancing health for everyone, every day RMH Imaging provide a comprehensive diagnostic and therapeutic imaging service for our patients and refers, using the most up to date equipment and dose reduction strategies.

- Perform investigations, procedures and dictate reports, as per the daily roster during normal working hours.

 - Provide advice as to the optimum radiological investigations for individual patients.
 - Attend and conduct clinical-radiology conferences.
 - Present interesting cases to regular academic meeting of radiologists and radiology registrars.
 - Participate in research projects.
 - Assist in the teaching of undergraduate medical students and other groups within the hospital.
 - Take responsibility for the after-hours radiological service of the hospital on a pro-rata basis, under the supervision of the consultant radiologist on-call.
