The IUS clinician works collaboratively within a multidisciplinary team to provide comprehensive inpatient and outpatient care, as required to support service delivery and continuity of care. The role requires effective clinical decision-making, clear communication, and the ability to prioritise workload in a fast-paced tertiary healthcare environment.

In addition to direct patient care, the position supports safe handover processes, clinical documentation, adherence to departmental and organisational policies, and participation in quality improvement, teaching, and supervision activities where appropriate. The role is integral to maintaining efficient patient flow and high standards of care within the Gastroenterology and Hepatology service.
