




- Serve as the executive lead for the Shared Ward Governance Project, optimising multidisciplinary collaboration and bed management efficiency in the inpatient setting.
- Provide expert inpatient and outpatient care.
- Drive the department's research agenda, fostering an environment where clinical inquiry is integrated into standard care.
- Actively seek grant funding opportunities and provide expert supervision for Higher Degree Research (HDR) students (PhD, MD, Masters).
- Contribute to organisation-wide and service/division initiatives and planning activities.
- Ensure risk management activities are completed, effective controls are in place and incidents are recorded, investigated and corrective actions implemented as far as is reasonably practical.
- Create a psychologically safe work environment where everyone feels safe to speak up. Monitor and achieve relevant KPIs and targets and operate within their allocated budget.
- Act as a mentor and advocate for registrars in the Nephrology advanced training program regarding clinical matters and professional issues.
- Work with the Director to promote stability and clear direction for our high performing individuals and teams, ensuring that necessary and appropriate resources are accessible to support service ambitions and prevent burnout.
