



POSITION SUMMARY

The Nuclear Medicine Technologist – Grade 1 completes diagnostic and therapeutic procedures according to hospital and department protocols, policies and procedures. In conjunction with the Nuclear Medicine Specialists NMTs assist with the provision of high quality patient and referrer focused NM services. Rotation through all services provided by the Department of Nuclear Medicine is required.

- Perform duties in accordance with Melbourne Health policies and procedures.
