## POSITION SUMMARY

The Lead Technical Officer role is integral to the daily fabrication and work flow operations of the Prosthetics & Orthotics Department. With the support of the Manager Prosthetics & Orthotics, the Lead Technical Officer is primarily responsible for:

- Supervision of technical staff
  - Produce a broad range of high-quality Prosthetics & Orthotic devices
  - Daily supervision and coordination of all technical and laboratory safety processes
  - Coordination and delivery of Technical Education for technical, clinical and student staff
  - Ensuring all staff are trained in Safe Operating Procedures for equipment and tools
  - Ensuring the laboratory and equipment/tools are maintained in safe condition
  - Coordination of stock and materials management
  - Lead innovation in the application of new materials and fabrications techniques
  - Quality control of fabrication outcomes
  - Supporting effective communication between technical and clinical staff
