

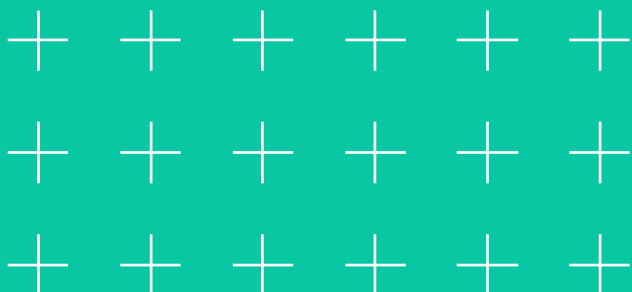

The Allied Health team provides integrated multidisciplinary care across the acute, subacute and community sectors of Melbourne Health (with the exception of North West Mental Health). Allied Health professionals and support team work to improve the patient's physical and psychosocial functioning. The Allied Health structure complements a series of new and exciting developments aimed at supporting our workforce and creating innovative solutions in order to provide excellent patient care.

KEY ACCOUNTABILITIES

- Work at least 75% patient related activities as per the Melbourne Health Allied Health benchmarks
- Provide evidenced based assessment and management of a wide variety of patients
- Demonstrate effective communication strategies within a multi-disciplinary team
- Practice person centred care and contribute to decision making with patients and carers
- Contribute to the operational needs of the department across a 7 day service model
- Participate in the staff clinical supervision program
- Provide supervision to grade 1 staff, students and allied health assistants as per discipline guidelines
- Manage risk and actively work toward implementing risk reduction strategies
- Work with senior clinicians and clinical services staff to establish clinical governance framework
- Display an understanding of quality improvement principles and actively participate in quality improvement activities
- Participate in the development, implementation and review of physiotherapy student education in conjunction with senior staff
- Assist in maximising opportunities to further expand the role of physiotherapists within the organization
- Demonstrate knowledge of wider organisation strategy, structure and goals
- Ensure direct reports receive regular feedback and participate in annual discussions.
- Contribute to organisation-wide and service/division initiatives and planning activities.
- Ensure training needs of direct reports are identified and undertaken.
- Ensure risk management activities are completed, effective controls are in place and incidents are recorded, investigated and corrective actions implemented as far as is reasonably practical.
- Create a psychologically safe work environment where everyone feels safe to speak up. Monitor and achieve relevant KPIs and targets and operate within their allocated budget.
- Take reasonable care for your safety and wellbeing and that of others.
- Work in your scope of practice and seek help where required.
- Work in partnership with consumers, patients and where applicable carers and families.
- Work collaboratively with colleagues across all RMH teams.
- Continue to learn through mandatory training and other learning activities.
- Seek feedback on your work including participation in annual performance discussion.
- Speak up for safety, our values and wellbeing.
- Prioritise wellbeing and ensure safe work practices are developed and adhered to in their area.
- Respect that the RMH is a smoke-free environment.

Formal Qualifications

- Recognised degree or equivalent in Physiotherapy
- Professional registration as a Physiotherapist with the Australian Health Practitioner Regulation Agency (AHPRA)
- Current Victorian Driver's Licence

- Effective verbal, non-verbal and written communication including conflict resolution skills
- Reflective practitioner and self-directed learner
- Collaborative practitioner: teamwork, promotes Physiotherapy/ Allied Health
- Risk Management and safe working principles in the hospital environment
- Time management and prioritisation skills
- Professional standards of behaviour and presentation
- Demonstrated ability to work as part of a team and modelling of interdisciplinary practice
- Ability to impart knowledge to staff at all levels as well as members of the wider community
- Previous participation in programme development
- High level organisational skills
