

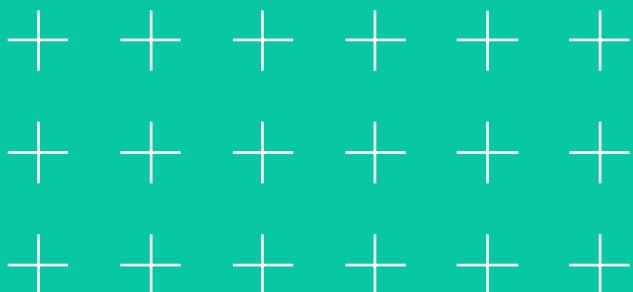
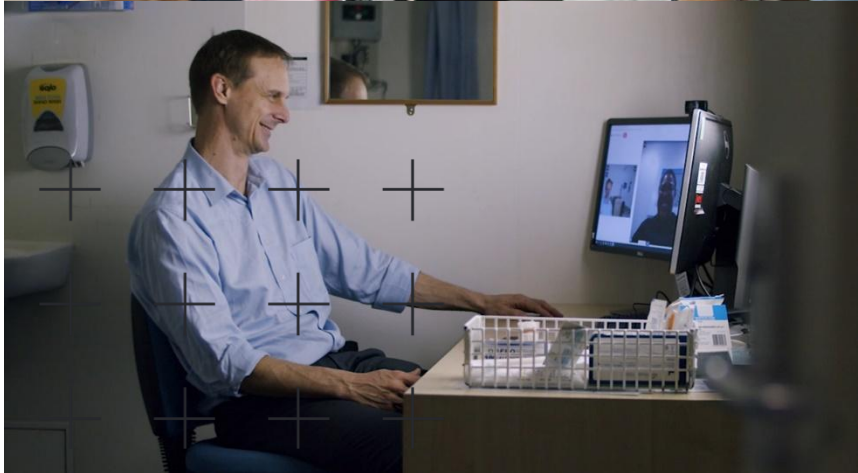

The Allied Health team provides integrated multidisciplinary care across the acute, subacute and community sectors of Melbourne Health (with the exception of North West Mental Health). Allied Health professionals and support team work to improve the patient's physical and psychosocial functioning. The Allied Health structure complements a series of new and exciting developments aimed at supporting our workforce and creating innovative solutions in order to provide excellent patient care.

## KEY ACCOUNTABILITIES

- Work at least 60% patient related activities as per the Melbourne Health Allied Health benchmarks
- Provide quality patient focused care through competent, evidence-based clinical skills relating to assessment, treatment and discharge planning
- Prioritisation of caseload and management of competing priorities including delegation where appropriate
- Contribute to the operational needs of the department across a 7 day service model
- Demonstrate multi-disciplinary health care approach that achieves desired patient outcomes
- Display sensitivity and knowledge of ethical and multicultural issues and provide culturally aware practice
- Actively participate in supervision from manager / clinical leader senior staff member and in Individual Development, Work Planning & Annual Discussions
- Display sound organisational skills through efficient time management, professional responsibility and accountability
- Display highly effective communication by demonstrating sound verbal, non-verbal and written skills
- Support student programs including supervision of students and teaching undergraduates and/or post graduate students
- Develop resources and effective use of resources in practice
- Deliver presentations to conferences or workshops
- Initiate continuous quality improvement activities and projects both within the clinical team and department as required
- Contribute to succession planning for Physiotherapists within the department in conjunction with the Physiotherapy Manager and other Senior Clinician Physiotherapists
- Demonstrate ability to assume extra responsibilities as requested by the manager
- Provide clinical supervision to direct reports as per discipline guidelines
- Ensure direct reports receive regular feedback and participate in annual discussions.
- Contribute to organisation-wide and service/division initiatives and planning activities.
- Ensure training needs of direct reports are identified and undertaken.
- Ensure risk management activities are completed, effective controls are in place and incidents are recorded, investigated and corrective actions implemented as far as is reasonably practical.
- Create a psychologically safe work environment where everyone feels safe to speak up. Monitor and achieve relevant KPIs and targets and operate within their allocated budget.
- Take reasonable care for your safety and wellbeing and that of others.
- Work in your scope of practice and seek help where required.
- Work in partnership with consumers, patients and where applicable carers and families.
- Work collaboratively with colleagues across all RMH teams.
- Continue to learn through mandatory training and other learning activities.
- Seek feedback on your work including participation in annual performance discussion.
- Speak up for safety, our values and wellbeing.
- Prioritise wellbeing and ensure safe work practices are developed and adhered to in their area.
- Respect that the RMH is a smoke-free environment.
