

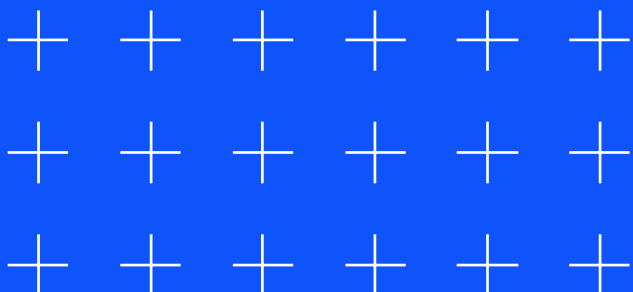

- FHGSA (Genetic Counselling) – or equivalent

Essential:

- Excellent interpersonal and communication skills.
- Excellent time management skills with focus on attention to detail.

- Involvement in Genetic Counselling professional activities.
- Involvement in research activities.
- Previous experience in the supervision of Associate Genetic Counsellors.
- Previous experience in the education and training of Associate Genetic Counsellors and training of staff in other disciplines.
- Previous experience in change management within a clinical service.
