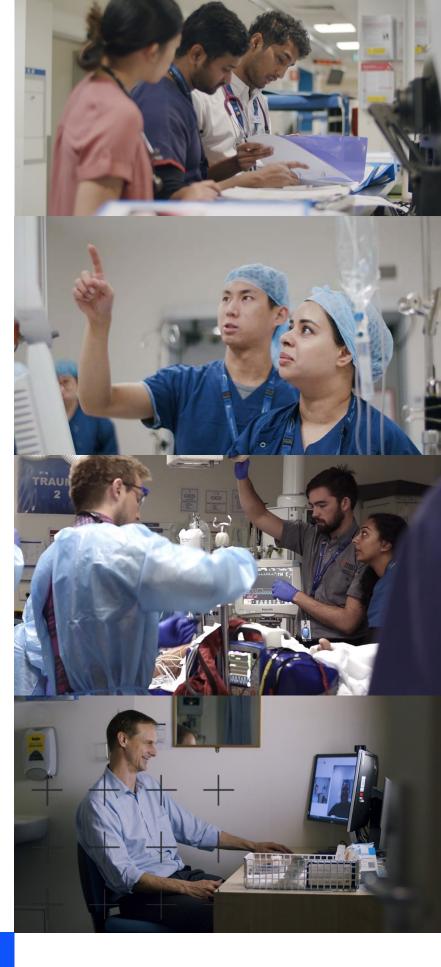
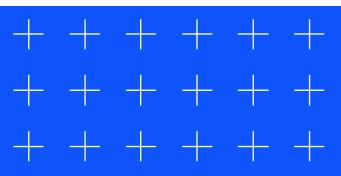

POSITION SUMMARY

The Victorian Infectious Diseases Reference Laboratory (VIDRL) is a leading Australian infectious diseases reference laboratory at the Peter Doherty Institute for Infection and Immunity (the Doherty), a joint venture between Royal Melbourne Hospital and the University of Melbourne located in Melbourne, Victoria. VIDRL provides the Victorian Department of Health with virology, mycology, parasitology and mycobacteria public health reference laboratory services, including surveillance, outbreak investigations, reference testing and research. VIDRL has national reference laboratory designations to the Commonwealth Department of Health for polio and enteroviruses, measles, viral haemorrhagic fevers and smallpox. VIDRL has WHO Collaborating Centre designations for Reference and Research on Influenza, Mycobacterium ulcerans, and Viral Hepatitis together with WHO Regional Reference Laboratory designations for poliovirus, measles and hepatitis B, and is a WHO National Influenza Centre.

This full time (1.0 EFT) role will provide support the Bacteriology, Mycology and Parasitology Laboratory, which provides rapid-turnaround diagnostic testing of a large number of pathogens of clinical importance including sexually transmitted, parasitic and fungal infections. As the Deputy Section Head, this role will deputise for the Section Herad when required, and is a senior position within the Bacteriology, Mycology and Parasitology laboratory.

Broad responsibilities will include:

- Work with team members in the Bacteriology, Mycology and Parasitology laboratory to assist with the delivery of an efficient diagnostic reference service.
- Conduct laboratory procedures in accordance with the instructions of the Section Head and provide deputising support as required.





• Support the development of new diagnostic assays for bacterial, fungal, and parasitic infections, and assess emerging technologies to improve laboratory efficiency and workflows.





KEY ACCOUNTABILITIES

- Participate in internal VIDRL committees and contribute significantly to the development and implementation of laboratory research and development initiatives.
- Develop and implement methodologies that are underpinned by critical thinking and using appropriate scientific and analytical tools
- Maintain high standards of quality and compliance within the section, ensuring all work is conducted in accordance with best laboratory practices at BSL-2 and within external accreditation frameworks including NATA, NPAAC, OTGR, and DAFF.
- Exhibit a comprehensive understanding of external accreditation and compliance frameworks relevant to laboratory operations.
- Participate in staff training and ensure that all BMP staff are adequately trained.
- To provide expert advice regarding the interpretation of laboratory results to medical, scientific and public health staff as appropriate.
- To have an understanding of budgetary processes including how to set and keep to budgetary targets.
- Support the Section Head in overseeing daily laboratory operations, staff supervision, and scientific activities, and provide deputising support as required.

- Provide expert advice and perform diagnostic testing for a broad range of bacterial, fungal, and parasitic pathogens.
- To maintain accurate records of results of tests performed and accurately interpret, validate and authorise test results.
- Take reasonable care for your safety and wellbeing and that of others.
- Work in your scope of practice and seek help where required.
- Work collaboratively with colleagues across all RMH teams.
- Continue to learn through mandatory training and other learning activities.
- Seek feedback on your work including participation in annual performance discussion.
- Speak up for safety, our values and wellbeing.
- Prioritise wellbeing and ensure safe work practices are developed and adhered to in their area.
- Respect that the RMH is a smoke-free environment
